**Time and Place:** The event is being held from 10 AM to 5 PM at 27 North Berwick Road, Wells, Maine. Set up starts at 8 AM. Breakdown must be finished by 7 PM. Please plan accordingly.

**Fees:** Fee is \$45.00 per show for a 10 x 10 space or if you pay in advance for all three shows by May 15, 2019, the total fee is \$120. You can rent more than one space. We are looking for Psychics, Healers, Artists, and Authors only. If you need help at your table, it's ok to bring helpers. Please bring your own 10 x 10 tent, tables, chairs, tablecloths, etc. Electricity is not available. All prices and fees for products and services are to be set by the vendor. All sales tax to be paid by the vendor to the State of Maine is the responsibility of the vendor not Elemental Energies with Chris Ann & Jeff. Admission to the event is free.

**Refunds:** No refunds issued one week prior to event and no shows. If you cancel, two weeks or more before the event, we will refund the money minus twenty-five percent.

**Food:** No food vendors are welcome as we a gluten free/dairy free facility. Please bring a cooler with your own lunch as NO FOOD is allowed in the shop.

**Advertising:** This is a juried fair for all vendors, including artists. All readers must give Chris Ann a free mini reading before their application being accepted.
